- 2. Review attribute requirements in Section 4 of this document to ensure you can meet our requirements
- Fill out the Trading Partner Form on the Smarter Sorting Landing Page:

- 4. Smarter Sorting will create a subscription at the Information Provider GLN + Target Market = U.S. level
- 5. Smarter Sorting will send an email to the Supplier's primary data synchronization contact when they are ready for the first publications
- 6. Publish items
 - a. Send all items as Initial Load
- Smarter Sorting will provide feedback on publications using the following method:
 a. RECEIVED CICs will be returned upon receipt of publication
- 8. Continue to send changes and corrections for all items
