1 PREMIER'S DATA SYNCHRONIZATION INFORMATION

1.3 Minimum Product Attributes for Data Synchronization

To meet the requirements of the Global Data Synchronization Network (GDSN) for each trade item, specific product attributes must be published. Without these, information from the GDSN cannot be shared among subscribing supply chain participants.

A common set of attributes, agreed to among Healthcare supply chain partners, known as the <u>Minimum Product Attributes</u>, ensures that all attribute requirements will be fulfilled with a single initial publication to the GDSN, regardless of supply chain relationships. Of the thirty-one <u>Minimum Product Attributes</u>, nine (9) may be assigned default or designated values if actual values are not known; and six (6) are dependent on the values of other attributes. Two (2) additional attributes to capture UNSPSC code values are highly desirable. All of the Minimum Product Requirements are listed with additional Premier Attribute Requirements in Attribute requirements of this guide.

Additionally, GS1 Healthcare US has identified a number of attributes recommended for the US healthcare supply chain. Furthermore, new attribute fields are being added to the GDSN to allow publication of data through the GDSN to the Global Unique Device Identification Database (GUDID). These attributes may also be populated in the GDSN and will be accepted by all subscribing supply chain participants.

2 STEPS TO BEGIN SYNCING YOUR DATA WITH PREMIER

- 1. Sign up with a GDSN-certified data pool (e.g., 1WorldSync) if you are currently not a customer. Learn about the implementation options offered by 1WorldSync and choose the option that works best for your company.
- 2. Obtain Education/Training from your data pool or solution provider.
- 3. Load items into your data pool (e.g., 1WorldSync)
 - Ensure your data is accurate (pack quantities, measurements, weights etc.)
 - Load all item levels in your packaging configuration (hierarchy) Each, Case, & Pallet
 - Review attribute requirements in Section 3 of this document to ensure you can meet Premier's requirements
- 4. Contact Premier to provide them with your GLN and data synchronization contact information
 - Complete the Premier Trading Partner Form located at: <u>www.1worldsync.com/premier</u>.
- 5. Premier will create a subscription based on your Information Provider GLN/Target Market = U.S.
- 6. Publish your existing and/or new items in the Production environment.
- 7. Manage Catalogue Item Confirmation (CIC) Responses from Premier
 - CIC with state of "ACCEPT" means that Premier has received your data, but no business decision has been made on the data.
 - CIC with state of "REVIEW" means that Premier is asking you look over your data due to discrepant data they cannot synchronize on.
 - CIC with state of "SYNCHRONIZE" means that Premier has integrated your data with their backend systems.
 - CIC with state of "REJECT" means that Premier did not accept your data.
 - **Note:** Premier is using the CIC status details. This will give you clarification on what is discrepant with your data.
- 8. Send ongoing item maintenance notifications through your GDSN Certified Data Pool (e.g., 1WorldSync) to Premier Inc.'s GLN.
