2 STEPS TO BEGIN SYNCING YOUR DATA WITH PRIMEROEDGE

2.1 Implementation Steps:

- 1. Review the attribute requirements for GDSN in section 3 of this document. For the complete listing of all GDSN and PrimeroEdge mandatory attributes, refer to the PrimeroEdge Attribute Guide here.
- 2. Complete the PrimeroEdge Trading Partner Form found on the PrimeroEdge landing page here. This will trigger the data sync process.
- 3. Have your complete and accurate item data loaded into your GDSN certified data pool and ensure it is ready for publication in Production.
- 4. PrimeroEdge will create a subscription based on Manufacturer's GLN

2.2 Publication Steps

1. PrimeroEdge requires their suppliers to publish ALL items to PrimeroEdge GLN 0866078000409.

Items should include:

- a. Items that are suitable for school kids in K-12 and originated in the United States
- 2. Publish all items with a Publication Type of "New"
- 3. Investigate and respond to "REVIEW" CIC responses. PrimeroEdge will provide feedback on publications using the following method



2.3 Catalog Item Confirmations (CIC's)

PrimeroEdge will automatically return a CIC message to the supplier. The CIC sent will be based upon the following:

CIC Messages:

<u>RECEIVED:</u> Items has been received, but PrimeroEdge has NOT made any GDSN validations. This response will typically be sent once publication for a specific document has been completed

<u>REVIEW:</u> Item does not pass PrimeroEdge GDSN validations or item has failed audit process and therefore has data discrepancies to be reviewed and addressed. PrimeroEdge will provide a reason as to why specific item hierarchy is in this state.

This response will typically be sent after validations and audits have been successfully completed, which typically can take up to 24 hours.

<u>SYNCHRONIZED:</u> Item has fully accepted and loaded into PrimeroEdge's internal system and will be updated as revisions occur. This response will be sent after all validations and audits have been successfully completed.

<u>REJECTED:</u> PrimeroEdge no longer wants to sync this item to their internal system or item has been delisted by PrimeroEdge.
