#### 2 STEPS TO BEGIN SYNCING YOUR RX DATA WITH AMERISOURCEBERGEN (ABSETUP)

- 1. Load your item data in your data pool.
  - Work with your data pool service provider for support, training, and education on how to load item data.
  - 1WorldSvnc subscribers must use Basic Item Setup and Amerisource Bergen playlists within Item Management (IM) platform. These playlists will ensure that you are not missing any information required by AmerisourceBergen for successful synchronization.
    - i. For help, review AmerisourceBergen Quick Sheet available within 1WorldSync Community Platform. You can also reach out to the 1WorldSync support team or other community members about any data synchronization related topics. Community moderator or other members will respond to you on this interactive platform.
  - Non-1WorldSync GDSN subscribers must work with their respective data pool service provider to ensure that you are able to send as many GDSN attributes as possible. Top off AmerisourceBergen specific attributes in the 1WorldSync Item Management platform. Contact 1WorldSync to get details on how to get access to their platform. - 2. Confirm with your company's internal AmerisourceBergen sales representative that a GLN subscription has been set up in the ABSetUp portal for the GLN you will publish from.
  - Instructions for creating a GLN subscription in the ABSetUp portal can be reviewed in the ABSetUp GDSN User Manual at https://1worldsync.com/trading-partners/amerisourcebergen-rx/
- 3. Publish items to AmerisourceBergen/Retail Insights (ABSetup) GLN 0860044000608.

AmerisourceBergen will gladly accept publication of your full item catalogue, or you may choose to publish only items needed for current new item set-up.

- Suppliers should publish all current items as INTIAL LOAD
- Suppliers should publish all new items as NEW
- 4. Manage Catalogue Item Confirmation (CIC) Responses from AmerisourceBergen/Retail Insights.
  - A CIC with the state of "SYNCHRONIZED" means that AmerisourceBergen has integrated your data into ABSetUp.

- 5. You can now login to ABSetUp and complete the top-off data to complete your item setup.
- 6. Send ongoing item maintenance notifications through your GDSN Certified Data Pool to the AmerisourceBergen/Retail Insights (ABSetup) GLN 0860044000608.
