1 OVERVIEW

This document is intended for use by the trading partners of Wakefern Food Corp, as a guide for the preparation and on-going support for the synchronization of product data via the Global Data Synchronization Network™ (GDSN®).

Data Synchronization is the electronic transfer of standardized **product** and **location** information between trading partners and the continuous synchronization of that data over time. When this data is exchanged via a central global repository - GS1 Global Registry™, it is referred to as **Global Data Synchronization**.

Product and location information includes the following, but is not limited to:

- Item attributes controlled by the supplier or brand owner (e.g. Global Trade Item Number (GTIN), Net Content, Dimensions, Weight, Brand, UPC code, Ingredients and Food Allergens)
- Global Location Number (GLN) - Locations involved in trade such as company headquarters, billing departments, and ship-to addresses

The Global Data Synchronization Network™ (GDSN®) is an automated, standards-based global environment that enables secure and continuous data synchronization. This allows all trading partners to have consistent item data in their systems at the same time, ensuring that all parties in the supply chain are working with the same data. The GDSN® helps to save time and money for all organizations by eliminating steps to correct inaccurate data.

As part of Wakefern's continuing focus to satisfy consumer demand for product information and to improve supply chain efficiencies for it and its trading partners, Wakefern has worked with other retailers and suppliers to help build the GDSN®. Global Data Synchronization provides tangible benefits for retailers and suppliers such as:

- Satisfy increased consumer demand for information about the products they purchase
- Cost reductions within the supply chain
- Elimination of hand keying for creation and maintenance of items
- Enabling real time updates for item maintenance
- Elimination of data errors resulting in more accurate foundational data
- Increasing the efficiency of your business
- Building the foundation for electronic collaborative commerce

An entity that provides its customer's data synchronization services and a single point of entry to the Global Data Synchronization Network™ (GDSN®) is called a data pool. Data pools must be certified per GS1 System standards to operate within the GDSN®. Data pools interoperate with the GS1 Global Registry and each other. Example: 1WorldSync Data Pool.

2.2 Steps to Begin Synchronizing Data with Wakefern

1. Sign up with a GS1/GDSN® certified data pool, Wakefern uses 1WorldSync for its data pool. A GS1/GDSN® certified data pool will educate trading partners about the implementation options that they offer. <https://www.gs1.org/services/gdsn/certified-data-pools-list>
2. Review documentation within this Implementation Guide to familiarize yourself with both the GDSN® and Wakefern processes and requirements.
3. Complete the Trading Partner Form on Wakefern's 1WorldSync landing page. <https://1worldsync.com/community/find-a-trading-partner/wakefern/> Please note your 13-digit Company GLN and Wakefern PO Vendor Number are required.
4. Wakefern will send a subscription for your data (Catalog Item Subscription - CIS) based on your GLN to your GS1/GDSN® certified data pool
 - Prior to publishing data with Wakefern, make sure that you have received our subscription for your product data. Wakefern uses the supplier's Global Location Number (GLN) to subscribe to product data. (See [Section 8](#) for definition GLN)
 - For suppliers that use the 1WorldSync data pool, please refer to the "Subscription Visibility Report" on Item Management to view the subscription Wakefern has in place for your company GLN.
 - a. In Item Management, click reports on the left side, then click *Subscription Visibility*, then click *Search* (a blind search will bring up all results). The Subscription Visibility will only show the Recipient's (in this case Wakefern) Master Subscription and the last time it ran.

5. Loading your data into your data pool:
 - Register your items with the GS1 Global Registry™
 - Perform an audit of **all** item data attributes (dimensions, weights, allergens, ingredients, etc.) to ensure completeness and accuracy.
 - Load all item data for each level of the product hierarchy (ie. packaging configuration - Each, Inner Pack, Case, Pallet, Display, etc.)

 6. Publish items to Wakefern
 - If you are setting up an item for the first time, the GTIN must be published with a Publication Type of “New” to Wakefern’s GLN 0341190000006.
 - If your items are already set up in Wakefern’s item catalog and assigned a Wakefern item code, publish these items with a Publication Type of “Initial Load”.

Initially, publish to Wakefern’s GLN **0341190000006** a limited number of items (5 - 10). Wakefern will monitor and review the publications. If they are successfully received you can then proceed with publishing all remaining GTINs. If the initial publications are unsuccessful, we will work with you to resolve the problem and process the publications into our PIM.

3 DATA SYNCHRONIZATION MESSAGING

3.1 Publication Types

Wakefern checks all **Initial Loads**, **Item Changes/Modifications**, and **New Item** messages for incoming Catalogue Item Notifications (CIN). If the publication type is sent incorrectly (e.g. a New Item is published as an Initial Load), the publication will fail when processed by our PIM and the publication will need to be resubmitted with the correct publication type.

“**New**” is to be used by a trading partner to introduce a new item to Wakefern.

At any time during the item set up process, through assignment of a Wakefern item code, if you need to process data updates, you must publish the updates as “**New**”. Do not use “**Modify**” or “**Correction**”, as this will prevent the data from flowing into the new item portal. The GDSN choreography of data publication will require you to utilize the **Republish** as “**New**” functionality in order to publish a previously published item as new. This functionality is available within the 1WorldSync Item Management platform, but may not exist within other data pools. Your specific data pool may require you to delete the publication in order to publish a previously published item again as “**New**”. Please contact them directly for instructions.

Please note: 1WorldSync requires you to wait 25 hours after deleting a publication before you can publish as “**New**”. This is applicable to all data pools. The system requires 25 hours to clear all records, CIC’s and previously published data in order to accurately publish the updated data.

“**Delete**” is used to stop the synchronization on an item and delete the publication. This publication type is not currently part of an automated process at Wakefern, and must be completed manually by the Data Synchronization Specialist. If you publish a delete please send an email notification to datasync@wakefern.com listing the GTIN’s to be deleted.

“**Initial Load**” is used to synchronize item data for items presently carried by Wakefern. All existing items assigned a Wakefern item code must be synchronized using this publication type.

“**Modify**” or “**Correction**” are used to update items already synchronized with Wakefern. This allows real-time, on-going item maintenance to ensure current data is always available.

3.1.1 ITEM CHANGES AND MODIFICATIONS

All item changes must be sent through your data pool. An item change or modification is not a publication type, but an operation within an Initial Load or New publication. At this time, Wakefern cannot accept changes/modifications for new items that are already in the process of being set up; such changes need to be **Published** as New. If your item is in the process of being set up in Wakefern systems and a Modify or Correction is transmitted for the GTIN, the GTIN may reject and you will need to begin the new item set up process from the beginning. Please remember, if you make updates to a previously published item, you must use the **Republish** as “New” functionality.

At all times, it is essential that you follow the GS1 GTIN Management Standard. For example, if the consumer net content changes, then a new GTIN (UPC) must be assigned. For more information on the GTIN Management Standard, please visit www.gs1.org/gtinrules. You may contact your data pool for more information or the Wakefern Data Sync team at datasync@wakefern.com.
Wakefern Food Corp requires all vendors to follow the GTIN Management Rules. All Net Content and Case Pack changes will require a new GTIN.

3.2 Catalogue Item Confirmation (CIC) - Responses from Wakefern

Wakefern has an auto-accept process to handle all publications received (CIC messages). After Wakefern receives the CIN, the message is subjected to matching and validation rules. The Catalogue Item Confirmation (CIC) response is generated immediately after those rules are executed.

1WorldSync users should review the “Sync Status Report” and the “Item Sync Exception Report” in the Item Management application to determine if synchronization was successful. **Please utilize the Wakefern Playlist within 1WorldSync Item Maintenance to ensure you have provided all required and requested attributes. By utilizing the Wakefern Playlist, you can spot errors and omissions immediately with online data validations and avoid item set up delays.**

3.2.1 WAKEFERN CIC RESPONSES TO INITIAL LOAD AND ITEM CHANGES

Synchronized: Item has been successfully updated in the Wakefern database and is synchronized to the assigned Wakefern item code in our item database.

Review: Item data has been received and differences in data have been identified requiring the data undergo further review.

3.2.1.1. CIC RESPONSE - REVIEW

- A CIC response of **Review** implies that after comparison of the data published, differences were found between the published data and the product data in Wakefern’s database, or an incorrect Publication Type was used. A Review status generates an internal notification for a Wakefern associate to review the differences found in the product data. Once an item is internally reviewed and audited, Wakefern has the ability to **Challenge** the vendor’s data.

Challenge: Wakefern may audit and challenge data elements, sending via email specific information regarding the data discrepancy. It is expected that the trading partner review the product data and where appropriate, publish corrections to the data. If the trading partner, upon its own internal review process, determines the published data is correct, you must report this information back to Wakefern, via email to datasync@wakefern.com. Examples of discrepancies are dimensions, net content, unit of measure, and others.

Reject: The item record failed to match an item in the Wakefern item database, for one of the following reasons:

1. The UPC on the “Each” level GTIN could not be matched in Wakefern’s internal systems
2. Wakefern could not find a match on the UPC on the GTIN’s above the “Each” level GTIN in the item hierarchy
3. The *totalQuantityOfNextLowerTradeItem* (1WS - Qty of Next Level Item) of the GTINs above the Each level, does not match Wakefern’s internal systems (total quantity of consumer units in the case).
4. An incorrect publication type was used.

Data synchronization standards support the use of Status Detail codes on Review or Reject CIC’s to further explain the reason for those CIC’s. **Wakefern does not currently support these codes; however, we are planning to make system changes providing us with the ability to communicate an appropriate Status Detail code sometime in the future.**

3.2.2 WAKEFERN CIC RESPONSES TO NEW ITEM PUBLICATIONS

Received: New Item has been received by Wakefern, but no business decision has been made on the item. Wakefern does not automatically validate any data at this time. If all attributes are published correctly, the item will be available in the Wakefern New Item Portal’s Data Sync Repository for you or the sales rep/broker to set up. The item will remain in a Received Status until you or the sales rep/broker submits the new item into the Wakefern New Item Portal.

Review: Check that you did publish using the publication type of “New”. If you did not, you will need to Republish as “New”. If you did, you or your sales person (or broker) has supplemented GDSN® data in the Wakefern New Item Portal, and has submitted the item for Category Manager Approval. The item (GTIN) will remain in Review status during the new item set up process. The final stage of the new item process is completed by Wakefern’s Master Data department. They can be reached at data.integrity@wakefern.com.

Synchronized: The New Item has been added to the Wakefern item database and assigned a Wakefern item code.

Reject: New Item has been rejected for one of the following reasons:

3.2.2.1. CIC RESPONSE - REJECT

The following circumstances will explain the reasons for a rejection of a New Item publication:

1. Category Manager has decided not to purchase this item.
2. The data structure has failed our audit and validation process requiring corrections and republication (example: *isDispatchUnit* indicator is false at all levels of the hierarchy).
3. No response generally means that Wakefern does not have the required subscription set up for the item. All subscriptions currently require a GLN. Please ensure you have submitted the Data Sync Vendor Fact Sheet. https://1worldsync.com/community/find-a-trading-partner/wakefern/#trading_partner-form
4. If you published a new item as anything other than new, including “correction, “modify,” or “initial load”, you could receive a REJECT status, as the Wakefern system would not be able to find a matching consumer UPC for that item.

5. The new item was updated, corrected, or modified in the GDSN® and a change/correction/modify operation was sent to Wakefern to update the GTIN. If you make updates to a previously published item, you must use the Republish as “New” functionality. This functionality is available within the 1WorldSync Item Management platform, but may not exist within other data pools. Your specific data pool may require you to delete the publication in order to publish a previously published item again as “New”. In order for you to correct this condition, you must contact datasync@wakefern.com, provide all relevant details including the high level GTIN, receive confirmation that Wakefern has updated the CIC from Rejected to Review, and then publish as “New”.
6. The Item is incorrectly deleted out of the Wakefern New Item portal for any reason.

In order for you to correct this condition, you must contact datasync@wakefern.com, provide all relevant details including the high level GTIN, receive confirmation that Wakefern has updated the CIC from Rejected to Review, and then publish as “New”.

Note: While a GTIN is in a CIC of Rejected, Wakefern will not be able to accept any other publication attempts on the GTIN until we, Wakefern, reset the CIC status to Review. Once Wakefern confirms the status of the GTIN is now listed as Review, you can go back and publish the GTIN as “NEW”.

4 ITEM HIERARCHY

4.1 Product Types

Trading partners are required to publish all *applicable* levels of the item hierarchy (i.e. each, pack, case, and pallet). Wakefern captures the item attributes published for each level of the item hierarchy and matches this data with the item data in our corporate item database.

All item hierarchy levels are assigned GTIN’s to uniquely identify the item at each level of the published item hierarchy. The levels of the item hierarchy are determined by the logistical and retail characteristics of the item.

Wakefern currently supports the following hierarchical product types (please note while the definitions are based on Global Data Synchronization standards, certain hierarchical combinations may not be supported by Wakefern’s system).

“PL” - Pallet - a pallet of a normal line or turn item. This product type may not have any parents, however may have children (DS, CS, PK, and EA).

Wakefern is only able to support a Pallet that has 1 unique child linked to it.

Example: PL > CA > EA is acceptable.

PL > CA > EA > CA > EA is not supported, since there are two different case levels linked to the pallet - please use “MX” or “Display Ready Pallet”.

“MX” - Mixed Mod - mixed module or display ready pallet that is not a normal line or turn item for ordering. This product type may not have any parents, however may have children (CA, PK, and EA) in multiple instances. When publishing an MX > CA > EA > CA > EA > CA > EA, it means that there are three different consumer units on the pallet being shipped. An example of this would be yogurt flavors. The Mixed Mod would contain 5 cases of vanilla, 5 of banana and 10 of strawberry, all shipped together on one pallet. To publish this type of item, it would need to have the “MX” Product Type at the Highest Level of the published hierarchy.

“CA” - Case - for most items, the standard shipping unit level. Can be linked to a PL or MX level. Multiple Cases should be linked to an MX, whereas, we request that hierarchies

containing just 1 unique case to be linked to a PL. A CA may contain multiple children for assortments (PK, and EA).

“DS” - **Display / Shipper/Mixed Case** - A display, shipper or mixed case, may be contained within one PL parent. Also, may have (CA, PK, or EA) children in single or multiple instances.

“PK” - **Pack / Inner pack** - the logistical or consumer unit between a case and each. May be contained within one parent (PL, MX, DS, CA). Also, may contain multiple children for assortments (EA). Can be a Consumer Unit or logistical unit.

“EA” - **Each** - the lowest level of the item hierarchy, intended to be the consumer unit and base unit. May be contained within one parent (PL, MX, DS, CA, or PK).

Here is a table of the appropriate product types with parents and children that are supported by Global Data Synchronization Standards. Please refer to the GS1 webpage for additional resources and documentation. <https://www.gs1us.org/upcs-barcodes-prefixes/additional-ways-to-identify-products>

Trade Item Unit Descriptor	Parents	Instances	Children	Instances
MX Mixed Module/Display Ready Pallet	None	N/A	DS*, CS, PK, EA	Single/Multiple
PL Pallet	None	N/A	DS, CA, PK, EA	Single
DS Display/Shipper, Mixed Case	PL, MX*	Single	CA, PK, EA	Single/Multiple
CA Case	DS, MX, PL	Single	PK, EA	Single
PK Pack/Innerpack	MX, PL, DS, CA	Single	EA	Single
EA Each	PL, MX, DS, CA, PK	Single	None	N/A

*While supported by GDSN® standards, Wakefern cannot process a publication with a Trade Item Unit Descriptor of MX that has a child of DS.

4.2 Assortments

Wakefern defines assortments as an orderable item that contains multiple UPC’s in the shipping unit (i.e. match box cars - an assortment of different car models within the master case). Assortments can be of three types; **Predefined (Fixed), Dynamic, or Random.**

A **Predefined (Fixed) Assortment** is defined as an assortment that comprises a fixed count of two or more different trade items, each identified with a unique GTIN that is declared on the package.

A **Dynamic Assortment** is defined As an assortment with a fixed total count comprised of two or more different trade items each identified with a GTIN, where the count of each trade item may change.

A **Random Assortment** is defined as an assortment that comprises items that are not uniquely identified on the package and are not marked for individual sale. (e.g., a bag of individually wrapped candies or color of toothbrushes).

Note: When publishing a dynamic assortment hierarchy, the *specialItemCode* attribute must be populated with **Dynamic_Assortment** on the level of the item hierarchy for which it would be applicable (i.e. a display with two unique consumer items, the *specialItemCode* attribute would apply to the display level of the hierarchy).

Currently, Wakefern supports most hierarchies, common and complex. If you have any complex hierarchies not described here, please contact Wakefern for additional information regarding the requirements at datasync@wakefern.com.

5 MANDATORY ATTRIBUTES

5.1 GDSN® Core Catalog Attributes

Wakefern has compiled a listing of GDSN® Attributes that are to be published for all applicable levels of a product hierarchy and/or product category.

Please note the different statuses of these attributes.

***Mandatory** - a GDSN® attribute that **must be populated** when publishing to Wakefern.*

***Mandatory (if Module invoked)** - are mandatory attributes when related data attributes are populated. Please refer to the Wakefern Attribute List for further details.*

***Requested** - these are attributes that Wakefern asks our trading partners to populate for all applicable hierarchies.*

Please see the **Wakefern Attribute Guide** and the **Wakefern Expanded Attribute Lists for Food, Non Food, and Pet** on our 1WorldSync landing page for a complete list of data attribute requirements. <https://www.1worldsync.com/wakefern>

5.2 Additional Wakefern Requirements

1. Wakefern requires that all trading partners publish the *isConsumerUnit*, *isDispatchUnit*, *isInvoiceUnit* and *isOrderableUnit* as “true/yes” for **at least one level of the hierarchy**.
2. Wakefern requires that all *netContent* and *netContent unitOfMeasure* be published as declared on the product packaging. **Where the packaging states multiple net contents (e.g. 16.9 fl oz and 500 ml), both must be published. *Reminder: ALL Net Content changes require a new UPC/GTIN.***
3. Dynamic assortment hierarchies must have the *specialItemCode* attribute populated with *Dynamic Assortment* on the level of the item hierarchy for which it would be applicable.
4. Wakefern requires that all trading partners publish the *gs1TradeltemIDKeyCode* and *gs1TradeltemIDKeyValue* for all levels of the hierarchy. This data is critical to the new item portal. Any errors and/or omissions will delay item set. Please ensure the value matches the GTIN for each specific level of the hierarchy.

6 PRIVATE LABEL

6.1 GTIN Allocation Rules for Private Label Products

All Private label products are required to be synchronized. Wakefern provides all private label suppliers with a unique UPC for all approved items at the consumer unit/each level. Global Data Synchronization requires the use of Global Trade Item Numbers to support the communication of product data through the Global Data Synchronization Network™ (GDSN®). The Wakefern assigned UPC is the foundation for creating and assigning the required GTINs to an item hierarchy.

- ShopRite Private Label UPC Prefix - 041190
- Example - UPC 0 41190 12345 X (where X represents the check digit)
- In the GDSN®, this UPC would be expressed with a GTIN of 0004119012345X
- Item Hierarchy - In the GDSN®, Trade Item Unit Descriptors define the package level for the item (Each, Pack/Inner Pack, Case and Pallet)
- As you assign GTINs in the Item Hierarchy, the Package Level value changes at each level
 - P004119012345X (P represents the package level)

When assigning the GTINs to each level of the product hierarchy, please follow these guidelines:

- The lowest or base level of the hierarchy (the EACH/Consumer Unit) GTIN will always start with “0”
 - Example: 0004119012345X will be the GTIN for the Consumer Unit/ Each - Base level.
- You will update the P digit by one for every level above that. (the P digit is the package level which equals the first digit of the GTIN)

- If your hierarchy is a CASE > EACH the GTIN hierarchy will be:
 - CASE: 1004119012345X
 - EACH: 0004119012345X
- The Check Digit, represented by X, will change with each level of the hierarchy as the packaging indicator changes
- If your hierarchy is a CASE > PACK > EACH the GTIN hierarchy will be:
 - CASE: 2004119012345X
 - PACK: 1004119012345X
 - EACH: 0004119012345X
- The Check Digit, represented by X, will change with each level of the hierarchy as the packaging indicator changes
- If your hierarchy is PALLET > CASE > EACH the GTIN hierarchy will be:
 - PALLET: 2004119012345X
 - CASE: 1004119012345X
 - EACH: 0004119012345X
- The Check Digit, represented by X, will change with each level of the hierarchy as the packaging indicator changes
- If your hierarchy is PALLET > CASE > PACK > EACH the GTIN hierarchy will be:
 - PALLET: 3004119012345X
 - CASE: 2004119012345X
 - PACK: 1004119012345X
 - EACH: 0004119012345X
- The Check Digit, represented by X, will change with each level of the hierarchy as the packaging indicator changes

- The Check Digit is a derived value and will change as the Package Level changes. If necessary, you can find a check digit calculator at:

6.2 Additional Wakefern Requirements for Private Label

- When a trade item is made specifically for Wakefern Private Label (ShopRite, PriceRite, Wholesome Pantry, etc.), the Brand Owner GLN attribute must be Wakefern’s GLN 0341190000006.

- The brandDistributionTradelItem Type = "PRIVATE_LABEL"

7 DATA POOLS AND SOLUTION PARTNERS

8 FREQUENTLY ASKED QUESTIONS

Do Direct Store Delivery (DSD) suppliers need to implement data synchronization?

Yes, Wakefern's DSD suppliers who are data sync capable need to provide their item data to Wakefern through the GDSN®.

Do random weight and bulk item suppliers need to implement data synchronization?

Fresh meat, seafood, produce, bakery and deli suppliers of random weight and/or bulk items are not required to participate at this time. To be clear, regardless of the product division, vendors that supply items that are manufactured and packaged with a UPC are being asked to comply with this program and publish product data through the GDSN®.

Please note that Wakefern is currently testing random weight hierarchies to ensure accurate data processing. If you have any questions or are interested in testing random weight publications please contact datasync@wakefern.com for more information.

Are suppliers that sell to a distributor that sells to Wakefern required to implement data synchronization?

If a supplier only sells to the distributor and not directly to Wakefern, they would need to discuss this with the distributor about who will publish the product data to Wakefern.

Is there a timeline for a supplier to respond to this request?

Yes, suppliers are being asked to publish their first item to Wakefern and sign with a data pool as soon as possible. If you are not publishing yet, you need to start doing so immediately.

If a supplier is synchronizing with another retailer, can they publish to Wakefern?

If you currently synchronize product data with another retailer, we ask that you take immediate action to begin synchronizing item data with Wakefern.

Why should a supplier respond to this request?

Data synchronization is not just communicating item data on a one-time basis. It is a process to keep data synchronized between trading partners during the life of a trade item. Data synchronization ensures that all changes that occur to an item are communicated to the retailers on a timely basis.

For these reasons, Wakefern has made Data Synchronization a standard business practice **required of all vendors** supplying Wakefern with bar-coded, consumer packaged products.

What is a Global Location Number?

A GLN is an acronym for "Global Location Number" and refers to the globally unique GS1 System identification number for legal entities, functional entities, and physical locations. A GLN is comprised of 13 digits that together represent a GS1 Company Prefix, Location Reference, and 'check digit'. Supply side trading partner locations generally include corporate

headquarters, regional offices, warehouses, plants, and distribution centers. Demand side trading partner locations generally include corporate headquarters, divisional offices, stores, and distribution centers.

What is a GS1 Company Prefix?

A company prefix is a globally unique number assigned to companies by GS1 member organizations (GS1 US in the United States) to create the identification numbers to the GS1 system. It is comprised of a GS1 prefix and a company number.

What is a Global Product Category?

A GPC code is an 8-digit number that represents a classification of products. It is a ‘flat’ classification system based on attributes and values. Global Product Classification is a required element of the global data based on attributes and values, and is a required element of the GDSN®. This information will be filled in the **globalClassificationCategory** Attribute, and you will need to enter the correct code value. Note: If you are not subscribing to 1WorldSync you will need to contact your data pool provider for a list of valid GPC Codes. To request a GPC code to be added to standards, work with your data pool provider to submit a change request.

What is a GTIN?

GTIN is an acronym for “Global Trade Item Number” and refers to the globally unique GS1 System identification number for products and services. A GTIN may be 8, 12, 13, or 14 digits in length, represented as GTIN-8, GTIN-12, GTIN-13, and GTIN-14, respectively.

Is data synchronization just another term for EDI?

No. EDI is used in the transmission of many e-business transactions (purchase orders, invoices, etc.), whereas data synchronization is the electronic transmission of standardized product and location information.

Is data synchronization an Information Technology (IT) function? Does it require IT resources?

Data Synchronization is a business process that uses technology in its implementation. For a successful implementation, it is recommended to have executive sponsorship and technology resources allocated to this program.

How do I contact the data sync team at Wakefern if I have any questions?

The data sync team at Wakefern can be reached at datasync@wakefern.com. When seeking assistance please provide the 14-digit high level (HiLvl) GTIN you are working on and why you are publishing the GTIN to Wakefern. Meaning, are you publishing the GTIN to be entered into the Wakefern new item portal for item set up, or are you publishing the GTIN to match/sync to an existing Wakefern assigned item code? That piece of information will greatly assist Wakefern’s Global Standard Specialists when looking for a resolution and not delay their research process.

I published my GTIN as new but I still don't see the item available for me to set up in the Wakefern item portal, where is the item?

There are a number of reasons as to why this could happen. Without having the GTIN and researching the issue, we cannot provide an answer to all possibilities in this document. However, here are some of the main reasons as to why a GTIN/item, with a printed/declared UPC would not show up in the Wakefern item portal:

- The incorrect Publication Type was used.
- The publication hierarchy is not built correctly. Example you have a Case linked to a Case Product Type, when the correct built would be CASE > EACH.
- You do not have a level of the hierarchy marked as consumer unit “yes” or “true”. This applies to standard UPC items, please see the second question listed in the Frequently Asked Questions section above about Random Weighted items.
- You have the consumer unit level of the hierarchy entered with a 14-digit *gs1TradeItemIDKeyCode* and Value (this attribute populates the item UPC field in the Wakefern item portal)
- You did not enter a value for the *gs1TradeItemIDKeyValue* or you entered an incorrect value
- Wakefern is not subscribed to your GLN. We are unable to accept any GTIN publications from a GLN not in our database.
- The status of the GTIN is listed as “Failed - Sending to Subscriber”. This means that the GTIN transmission failed when sending from you to Wakefern and we did not get the publication.
