## **1 TRIMARK USA SYNCHRONIZATION INFORMATION**

TriMark USA has joined the 1WorldSync by Syndigo Item Management platform to synchronize product content with brand owners and information providers.

They require robust product content to support their Product Detail Pages (PDPs) website and mobile apps. GDSN allows them to expand their current data ingestion capabilities. All brand owners and information providers can use this document to learn how they can synchronize their product content with TriMark USA via GDSN.

## **2 STEPS TO BEGIN SYNCING YOUR DATA WITH TRIMARK USA**

### **2.1 Implementation Steps:**

1. Sign up with a GDSN-certified data pool, if not already subscribed. TriMark USA uses 1WorldSync as their data pool.
2. Fill out the Trading Partner Form (TPF) on the TriMark USA Landing Page:  
<https://1worldsync.com/trading-partners/trimark>
  - TriMark USA will create a subscription based on the GLN shared via the Trading Partner Form.
  - We will inform you via email when we are ready to receive your item data via 1WorldSync.
3. Prepare your item data into your home data pool/platform and ensure it meets TriMark USA, Inc product content requirements as outlined in the Attribute Guide on the TriMark USA landing page or Section 3 of this document.

### **2.2 Publication Steps**

1. Publish your items to TriMark USA GLN 0840107600006:
  - Publish items requested by TriMark USA or brand owners are welcome to share their entire product catalog.
  - TriMark USA supports all major restaurants, both independent and chain establishments as well as hospitals, schools, and entertainment venues across the United States, and will accept your full US catalog if published.
2. Publish the item using the highest level of the hierarchy as “New”. (i.e. If you have a Case and an Each, publish the item at the case level).
3. Investigate and respond to any CIC (catalog item confirmation) responses that are not ‘**Synchronized**’. \*\*(See section 2.3 for information on all CIC messages and actions that need to be taken.).

## **2.3 Catalog Item Confirmations (CICs)**

TriMark USA will automatically return a CIC message to the supplier of “Received”. However, other CIC messages may be sent back that require action from the supplier. The following CICs will be sent based on the following:

### **CIC Messages:**

**RECEIVED** (Auto Generated): Items have been received, but TriMark USA has NOT reviewed the data to ensure its completeness. This response will typically be sent once to confirm receipt, and an updated CIC will follow once the data has been reviewed.

**REVIEW:** The item does not pass TriMark USA GDSN validations, or the item has failed the audit process and, therefore, has data discrepancies to be reviewed and addressed. TriMark USA will provide a reason as to why a specific item hierarchy is in this state for the applicable attribution so that the supplier can update the item data as required.

**SYNCHRONIZED:** The item has been fully accepted and ingested into TriMark USA internal system and will be updated as modifications and corrections occur. This response will be sent after all validations and audits have been completed.

**REJECTED:** TriMark USA no longer wants to receive publications or updates for this item to their internal back-end system, or the item has been discontinued by the manufacturer or delisted by TriMark USA.
