Our Ask:

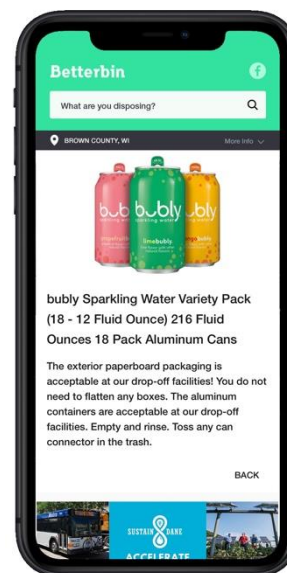
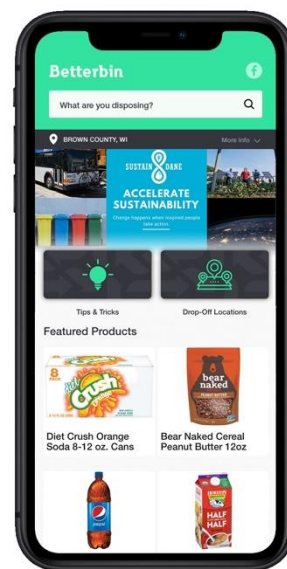

3 STEPS TO BEGIN SYNC'G YOUR DATA WITH BETTERBIN

1. Have your accurate item data loaded into your home data pool and ensure it is ready for publication
 - a. Contact your data pool for any education you might require to complete this step
2. Fill out the Trading Partner Form on the Betterbin Landing Page:
 - a. <https://www.1worldsync.com/community/customers/betterbin/>
3. Betterbin will create a subscription at the Information Provider GLN + Target Market = U.S. level
4. Betterbin will send an email to the Supplier's primary data synchronization contact when they are ready for the first publications
5. Publish items
 - a. Send all items as Initial Load
 - b. Betterbin is asking for the basic CPG GDSN attributes to help determine your items eligibility to be recycled
 - c. Publish at any level of your item hierarchy; Betterbin will only ingest information at the EACH/Consumer Unit level
6. Betterbin will provide feedback on publications using the following method:
 - a. RECEIVED CICs will be returned once a day
7. Continue to send changes and correction for all items

4 ATTRIBUTE REQUIREMENTS

In addition to the GDSN Mandatory attributes, Betterbin strongly recommends sending image information on the EACH/Consumer Unit level. See table below for image attributes.

1WorldSync Attribute Name	Global Data Dictionary Name	Attribute Requirements	GDSN Definition
Referenced File Type Code	typeOfInformation	M	The file type that is being referenced. Example: Product Image, MSDS, SDS
File Format	fileFormatName	M	The name of the file format. Examples: PDF, JPEG, BMP etc.
URL	uniformResourceIdentifier	M	Simple text string that refers to a resource on the Internet, URLs may refer to documents, resources, people, etc.
File Name	fileName	C (Required if Type Of Information contains the value "PRODUCT_IMAGE")	The name of the file that contains the external information.
Content Description	contentDescription	R	Free form description of the content of the file.
File Effective Start Date	fileEffectiveStartDateTime	R	The date this image is the current image for this trade item.
